On the basis of public consultation under Section 130 of Act No. 127/2005 on electronic communications and on amendment to certain related acts (the Electronic Communications Act), as amended (the "Act") and on the basis the results of public consultation based on Section 130 of the Act and decision of the Council of the Czech Telecommunication Office (the "Office") under Section 107(8)(b)(2) of the Act, and in order to implement Section 17(4) of the Act, the Office as the appropriate state administration body under Section 108(1)(b) of the Act hereby issues this

Measure of General Nature No. OOP/13/04.2008-3, amending Measure of General Nature No. OOP/13/07.2005-1, laying down the extent of the data required to be contained in the application for individual authorisation for the use of radio frequencies

Article 1

Measure of General Nature No. OOP/13/07.2005-1, laying down the extent of the data required to be contained in the application for individual authorisation for the use of radio frequencies, is hereby amended as follows:

In Article 2, Paragraph 3, after the end of Clause n), add Clauses o) to q), which, including footnote No. 4. should read as follows:

- "o) requirement for the network_id identifier⁴⁾ value (for broadcasting under the DVB-T standard);
- p) requirement for the transport_stream_id identifier⁴⁾ value (for broadcasting under the DVB-T standard):
- q) the service id identifier⁴⁾ value (for broadcasting under the DVB-T standard);

Article 2 Effect

This Measure of General Nature comes into effect on 1 May 2008.

Explanatory Memorandum

Measure of General Nature No. OOP/13/04.2008-3 amends the current Measure of General Nature No. OOP/13/07.2005-1. The purpose of the amendment is to extend this Measure of General Nature, which should also cover the obligations specified in Network Plan No. SP/4/04/2008 of data network, data stream and network service identifications in terrestrial digital television broadcasting. According to the proposed network plan, some of the identifiers that must be indicated in the individual authorisation are to be proposed by the application. Having considered them, the Office will lay them down. On the basis of this information, the Office will maintain a publicly accessible database and the applicant must therefore submit the data together with the application for individual authorisation. In addition, on the basis of the Electronic Communications Act – Section 18, concerning the "issuing of the authorisation to use radio frequencies" – it is set out in Subsection 1) Clause e) that the Office should indicate in this Measure the "identification numbers and codes", if they are necessary for the given type of radio communication service. For the above reasons, it is necessary to modify the text of Measure of General Nature No. OOP/13/07.2005-1 in which the range of these data is specified.

On the basis of Section 130 of the Electronic Communications Act and in accordance with the Czech Telecommunication Office's Rules for consultations at the discussion site, the Office published at the discussion site its draft amendment to the Measure of General Nature and an invitation for comments on 13 February 2008.

The Office did not receive any comments during the 14-day commenting period.
